Application deadline: All applications must be submitted by Friday, March 26th, 2017. Late applications must include a late fee of \$25. There will be no exceptions. World Ice Arena reserves the right to limit the number of entries, eliminate events, and refuse late entries. There are no refunds or credits under any circumstances.

Entry Fees: The first individual event will be \$50, and each additional event will be \$25. Tots and Pre-Alpha through Delta skaters who wish to skate **only** in compulsory may do so for a fee of \$30. Group events are \$50 plus a \$15 fee per skater. Fees may be paid by cash or credit card. There are no credits or refunds.

Registration: Please Check-in 45 minutes prior to warm-up time.

Music: You must submit music in the form of an MP3 by e-mail by 3/20/17. Compact Discs and cassettes will not be accepted. Please bring an additional copy of your music with you on an electronic device such as a smartphone or tablet. There will be no CD player available.

Judges: All teams must provide one certified judge for every five competitors. All judges must be current professional members of the ISI.

Warm-ups: Each skater will be provided with a 3-5 minute warm-up prior to his/her event.

Schedule: A complete competition schedule will be posted on our website at www.worldice.com one week before the competition. Inquiries should be sent to Sally Watkins at swatkins@worldice.com.

Video/Picture: No one is permitted into the hockey boxes to take pictures. All spectators must remain in the bleachers to view the competition and take pictures. Professional pictures and video will be available for purchase.

Food: Outside food and drinks are not permitted in the facility. World Ice Café will be open during the event.

Rink Size: Rink is regulation size: 85 feet X 200 feet.

Individual Awards: Awards will be issued to competitors in 1st-3rd Place. Awards will be presented on the podium only during the awards ceremonies.

Team Awards: Trophies will be awarded to the top three teams.

Team Points: Team Points are awarded as follows for all individual, partner, and group events:

1st Place: 5 points + 1 Participation Point
2nd Place: 4 points + 1 Participation Point
3rd Place: 3 points + 1 Participation Point
4th Place: 2 points + 1 Participation Point
5th Place: 1 points + 1 Participation Point
6th Place: 0 points + 1 Participation Point

Only for the following team events- Kaleidoskate, Pattern, Production, Synchronized Teams (Dance / Formation / Skating), and Team Compulsories- team points are as follows:

1st Place: 25 points + 5 Participation Point
2nd Place: 20 points + 5 Participation Point
3rd Place: 15 points + 5 Participation Point
4th Place: 10 points + 5 Participation Point
5th Place: 5 points + 5 Participation Point
6th Place: 0 points + 5 Participation Point

Skater Eligibility

- All competitors must be current individual or professional member of ISI up to and including the date of the competition. Skaters who are not current ISI members must add \$15 to the first event.
- Skaters are expected to compete at their true ability and to uphold high ethical standards.
- All competitors must compete at their highest ISI test level passed and all tests must be registered with the ISI national office at least 30 days prior to the competition date.
- Skaters in the Pre-Alpha through Delta levels may not compete in events offered only to Freestyle 1 or above.
- This competition will be held in strict accordance with the 2016 ISI Handbook and Rule Revisions.

Members of USFS who are also individual registered members of ISI may compete in accordance with the USFS/ISI Joint Statement of Policy. USFS skaters must check with their home club to determine if they need written permission to compete. USFS skaters must pass the ISI test level in which they wish to compete and must register those tests with ISI. The ISI skating level must be based on a skater's USFS test level, as specified in the ISI Competitor's Handbook, as follows:

Solo Compulsory

Tot Solo Compulsories (half ice, no music):

All tot competitors must be under 6 years of age as of April 29th, 2017.

Tot 1: proper way to fall and get up, marching in place, march while moving

Tot 2: two-foot hop in place, single swizzle, beginning two-foot glide

Tot 3: push and glide stroking, dip, forward swizzle

Tot 4: backward swizzle, two-foot or one-foot snowplow, backward wiggle

There is no penalty for the quantity of swizzles wiggles, strokes or crossovers performed in the Tot-Beta levels. Only the quality of these maneuvers is judged.

Solo Compulsories (no music)

Elements may be performed in any order. Freestyle 5 and below will skate half ice only.

Pre-Alpha	Forward swizzle, backward swizzle, one-foot glide
Alpha	Forward stroking, forward crossovers (right over left), one-foot snowplow
Beta	Backward stroking, backward crossovers (right over left), T-stop right foot behind
Gamma	Right outside 3-turn, right forward inside Mohawk combination, hockey stop
Delta	Forward outside and inside edges, right forward inside three-turn, bunny hop
Freestyle 1	Waltz jump, two-foot spin, forward spiral
Freestyle 2	Waltz jump/Tap-toe jump/3-turn or mohawk/ ½ Flip jump sequence, dance step sequence, one-foot spin
Freestyle 3	Toe loop or toe walley, change foot spin, dance step sequence
Freestyle 4	Loop Jump, sit spin, two backward arabesques (2 different feet, either edge)
Freestyle 5	lutz, axel, camel-sit-upright
Freestyle 6	Double salchow, axel-half loop-flip jump, sit change sit spin
Freestyle 7	Double toe loop, flying camel, two toe walley jumps in a row
Freestyle 8	Double flip jump, double loop jump, flying sit spin
Freestyle 9	Double lutz; axel double loop jump combination; flying camel spin into a jump sit spin

WAIVER AND RELEASE TO ICE SKATE

In consideration of receiving permission from World Ice Arena (Flushing Meadows Corona Park), RD Management LLC, Eckstein Development LLC, City of New York, City of New York Department of Parks & Recreation, or any of their agents, servants, designees, assigns, employees, members, successors, departments, subsidiaries, parents, affiliates and/or their heirs (hereinafter "RELEASEES"), to ice skate, play hockey, figure skate, take lessons, participate or be a spectator at the World Ice Arena located at 13135 Avery Avenue, Flushing, New York 11355.

I HEREBY EXPRESSLY ACKNOWLEDGE AND AGREE:

(1) TO ASSUME ALL RISK AND RESPONSIBILITY for any injuries or other damage I may sustain and any damages I may cause to RELEASEES, their employees, departments, subsidiaries, parents, agents, designees, assigns, successors, and/or heirs, guests, invitees or lessees or any other person in connection with my reason for being on the premise under control of THE RELEASEES (including anything in connection with equipment rented from the above mentioned entities or their affiliates).

(2) TO THE FULLEST EXTENT PERMITTED BY LAW, TO RELEASE THE RELEASEES, from ALL CLAIMS OF LIABILITY for any injuries (including death or dismemberment) which I may sustain or any damage that may be caused to me or my property in connection with my activities at the World Ice Arena (Flushing Meadows Corona Park) including, without limitation, injuries that may be caused from any equipment rented from the above mentioned entities or their affiliates.

(3) I WILL NOT SUE OR BRING LEGAL ACTION AGAINST the above named RELEASEES, their affiliates or their respective administrators, employees, or instructors and owners or lessors of the property.

(4) That the undersigned individual is in adequate physical condition to participate in all activities and events at the World Ice Arena.

(5) I authorize the RELEASEES, to use photographs, videotape, or any other record of the events which may depict me at their discretion, without compensation paid to me.

SAFETY, SUPERVISION AND YOUR OBLIGATIONS

(6) I acknowledge that the rules and regulations of World Ice Arena (Flushing Meadows Corona Park), as well as the duties and responsibilities of skaters as set forth under the laws of the State of New York are posted throughout the premise and which State Law as pertaining to the Responsibilities of skaters are as follows:

EACH ICE SKATER SHALL: (a) maintain reasonable control of his speed and course at all times; (b) heed all posted signs and warnings; (c) maintain a proper look out to avoid other skaters and objects; (d) accept the responsibility for knowing the range of their own ability to negotiate the intended direction of travel while on ice skates and to skate within the limits of that ability; (e) refrain from acting in a manner which may cause or contribute to the injury or himself or any other person; and (f) abide by the World Ice Arena (Flushing Meadows Corona Park) Rules.

In addition, I agree to obey said rules and regulations and all State Laws. I fully understand that ice skating is a very dangerous sport and recreational activity. I acknowledge and fully understand that each skater and participant will be engaging in activities that involve the risk of serious injuries (including temporary or permanent); death and social and economic losses which might result from the RELEASEES actions, inactions or negligence, but also actions, inactions or negligence of others, the conditions of the premises or any equipment use and/or rental. Further there may be other risks not known to the RELEASEES and myself not reasonably foreseeable at this time that shall likewise be included in this release.

(7) I understand that if I feel there is insufficient supervision or that the RELEASEES are not complying with their duties and responsibilities posted, I shall cease my activity and advise the RELEASEES of the condition. I also understand that if I feel there is insufficient supervision or that the RELEASEES are not complying with their duties and responsibilities posted, I shall immediately direct the child identified in this release and all children under my care and supervision to cease their activity and advise the RELEASEES of the condition.

(8) In order to maintain a safe and secure environment for all patrons and participants, parents/guardians must assist in doing so by watching, supervising, monitoring, and controlling the actions and activities of the child/children identified in this this release along with all other children they have brought with them to World Ice Arena (Flushing Meadows Corona Park). It is acknowledged and agreed that I will supervise, monitor and control the child/children identified in this release to assure that they comply with all rules and regulations for participating in the activities that they are engaged, which shall include, but not be limited to, complying with the rules identified in Paragraphs 6(a) through 6(f) this release. In addition, should the child/children identified in this release fail to comply with any of the rules or regulations for skating or participating in any activity at World Ice Arena (Flushing Meadows Corona Park), I will immediately direct them to cease such actions and remove them from the ice.

(9) My agreement to supervise, monitor, and control the child/children identified in this release (along with all other children under my care and supervision during my visit to World Ice Arena (Flushing Meadows Corona Park)) is a material representation of this agreement and, in the event, that I fail to properly carry out my obligations, I shall be liable to RELEASEES for any and all damages sustained by them that is attributable to my failure to supervise or perform my obligations under these provisions. I agree that I waive any claimed immunity from suit as a result of my parental/guardian relationship and that RELEASEES shall be permitted to maintain an action over and against me relative my duty and responsibility to supervise, monitor, watch, and control all children in my care during their visit to World Ice Arena (Flushing Meadows Corona Park).

ADDITIONAL OBLIGATIONS

(10) Should any provision of this Waiver and Release be held invalid or unenforceable by any court of competent jurisdiction, all other provisions shall continue in full force and effect. It is further acknowledged and agreed that this agreement shall be construed consistent with its intent, which is to the limit liability of the RELEASEES.

(11) LIMITATION: No action shall be commenced or maintained against World Ice Arena (Flushing Meadows Corona Park), RD Management LLC, Eckstein Development LLC, City of New York, City of New York Department of Parks & Recreation, or any of their agents, servants, designees, employees, successors, heirs, affiliates, partners, subsidiaries, members, or parent entities upon any claim based upon, or arising out of, your visit to World Ice Arena (Flushing Meadows Corona Park), use of its facilities, or use of any equipment rented by you, unless such action is commenced within one year after the claim arose. This provision shall also apply to claims arising out of this agreement, bodily injury (including death and dismemberment) sustained during your visit to World Ice Arena (Flushing Meadows Corona Park), and property damage sustained during your visit to World Ice Arena (Flushing Meadows Corona Park). This provision shall apply to the current visit and all future visits.

(12) VENUE: I acknowledge and agree that notwithstanding the foregoing, should I bring a lawsuit against RELEASEES, I agree that the venue for any such action shall be in the Supreme Court of the State of New York, County of New York, which is the County where the RELEASEES maintain their primary place of business.

(13) INDEMNIFICATION/HOLD HARMLESS/RELEASE: I acknowledge that there have been no representations made to me by the RELEASEES and I AGREE, TO THE FULLEST EXTENT PERMITTED BY LAW, TO HOLD THE RELEASEES HARMLESS for and from any injury or loss that I may cause to any other individual or the premise while on the premise. I FURTHER AGREE, TO THE FULLEST EXTENT PERMITTED BY LAW, TO INDEMNIFY the above set forth RELEASEES in the event of any such injury or loss for which they may be held responsible. I FURTHER AGREE, TO THE FULLEST EXTENT PERMITTED BY LAW, TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE RELEASEES from any and all claims brought by anyone that arise out of my visit to World Ice Arena (Flushing Meadows Corona Park), including those relating to any accident caused by, or involving any child under my care and supervision. In addition, RELEASEES shall be entitled to recover all actual attorneys' fees incurred in the defense of any action brought by me or any child under, or otherwise subject to, my control or supervision, that arises out of my or

their visit to World Ice Arena (Flushing Meadows Corona Park). RELEASEES shall be entitled to recover all attorneys fees actually incurred by them in enforcing any of their rights under this agreement.

(14) This release shall be in full force and effect notwithstanding the fact that I may be utilizing or otherwise renting equipment or other products owned or otherwise controlled by the RELEASEES.

(15) CURRENT AND FUTURE VISITS: This waiver and release shall apply to the current visit and all future visits.

(16) I understand there are no credits or refunds for any reason and admission and/or skate rental or other equipment rental, and lessons are non-transferable.

(17) I am at least eighteen (18) years of age or I am the parent/guardian of the individual named below, and have the legal capacity to enter into this waiver and release.
